- On the application screen, complete your steps step by step by entering the necessary information/uploading the documents in the Personal Information, Contact Information, High School Information, Exams-Documents and Selected Programs (Maximum 3 programs can be selected).
- Documents to be Added to the System for Online Application:
 - ✓ Passport Photo,
 - ✓ Passport Copy or ID Photocopy,
 - ✓ High School Equivalency Certificate (high school diploma for those who do not have this document)
 - ✓ High School Grade Certificate, (Transcript)
 - ✓ Other YÖS Result Document determined by TRYÖS and Senate in Application and Registration,
 - ✓ TÖMER Certificate (IF AVAILABLE).

ARTICLE 5 – Quotas, application process and preferences:

- 1) The department/program proposal regarding the quotas to be allocated to the associate degree and undergraduate level primary education programs of the units that will accept students from abroad or foreign nationals and special conditions, if any, are determined by the unit board and submitted to the approval of the Higher Education Council after being decided by the Senate. (It has been determined that 10% of the quotas in Teaching, Law, Medicine and Dentistry programs will not be exceeded for Turkish citizens studying abroad, Turkish citizens whose nationality is Turkish and candidates with a Blue Card, as per the relevant article.) Adıyaman University is free to fill the announced quotas. When necessary, reserve and additional placements can be made by transferring quotas between departments/programs (except Medicine, Dentistry and Pharmacy) for which applications are not made or quotas are not filled.
- 2) Applications are made online through our website between the dates announced in the academic calendar. The documents specified in the application announcement are attached in full and with the method announced in the announcement.
- 3) Applicants can only take one of the International Exams they have, the YÖS exams accepted by the Senate of our University, and the TR-YÖS exams. Online exams will not be accepted.
- 4) The validity period of the exams valid for the admission of foreign students is two years. There is no time limit for exams (Abitur, International Baccalaureate, GCE, Tawjihi etc.) that are in the status of high school graduation exam. The exam score and graduation grades shown in Annex-1 are taken into account when placing in the quota of foreign or foreign students of the University. The base scores of the exams arranged in the table in Annex-1 can be changed with the decision of the Senate.
- 5) For applications to foreign or foreign student quotas, firstly TR-YÖS and then only the Foreign Student Exam (YÖS) accepted by the Senate of our University is valid. Candidates with a score of 300 for Pharmacy and 350 for Medicine and Dentistry from the TR-YÖS exam can apply. A minimum of 80 YÖS points or equivalent SAT score for Medicine and Dentistry from the Basic Learning Skills/General Aptitude Test in the YÖS exam organized by other state universities. ; Applications to the pharmacy program can be made with a minimum score of 70 YÖS and equivalent exam scores such as SAT. The necessary information, if any, special conditions and explanations for the preferences are announced on the University's website. For other departments, applications can be made with a minimum of 40 points or more from YÖS's accepted by our Senate. YÖS condition is not required for Vocational Schools.

- 6) Candidates can apply to a maximum of three diploma programs. Applications to these programs will be made online between the dates specified in the academic calendar of the University.
- 7) Candidates can apply to associate degree programs with diploma or equivalent exams specified in Annex-1 table.
- 8) Candidates who have previously graduated from any program from higher education institutions in Turkey are not required to have a TÖMER certificate.

ARTICLE 7- Evaluation and Placement:

- a) **Evaluation and placement;** The exams to be used in the placement process of the university from abroad are given in Table 1. Provided that they have taken one of the equivalent exams in Table 1 and have achieved the minimum score shown in the table; In the process of placing students in the university's quota from abroad, evaluation is made over a total of 100 points and according to the priority order given below.
- b) Prospective students can apply to Medicine, Dentistry and Pharmacy programs only with TR-YÖS score. Candidates who have received a score of 300 for Pharmacy and 350 points or more for Medicine and Dentistry from the TR YÖS exam can apply. Candidate students can apply with the exams organized by other state universities accepted by the Senate of our University, with priority being the TR-YÖS score.
- c) The YÖS scores of other State Universities and the grade point average consisting of 60% of the YÖS score and 40% of the high school diploma for the other departments except TIP, Dentistry and Pharmacy are used as the basis for placement.
- d) Prospective students are placed in only one program according to the quota by first ranking YÖS and then the high school graduation grade from the highest score to the lowest, taking into account the order of their preference. In case of equal scores, priority is given to the younger candidate.
- e) As a result of the placement process, the lists of the candidates placed according to the scores obtained from the announced exams are arranged within the quota. Accepted candidates are sent an acceptance letter by the International Student Office Coordinator via e-mail and online application system, and they are asked to declare whether the relevant student will be registered or not
- f) Candidates who have the right to final registration must apply to the Registrar's Office within the registration period by completing the necessary documents for registration. Candidates who do not apply for registration or complete the registration process within this period lose their registration rights.

(Note: The originals (certified/sealed) of the documents will be hand-delivered to the International Student Office or the Registrar's Office on the dates to be announced later.)

1. Applications of candidates who do not meet the application requirements or have missing documents will not be evaluated. If erroneous information or false documents are detected in the application declaration of the candidates, the candidate loses his right to enroll and become a student, even if he has settled.
2. The YÖS score is determined based on the order of preference and the number of candidates from the same country admitted to a program. The number of candidates who have the right to register from the same country cannot exceed 20% of the total quota of the relevant program. If the quotas are empty, this threshold is not applied.

ARTICLE 8- Announcement and registration of results

1. Application evaluation and placement results are announced on the official website of ADYU International Student Office and Registrar's Office. Candidates are also not notified by mail. (Amended, ADYU Senate decision dated 02.12.2015 and numbered 23/12)
2. Registrations are made by the Registrar's Office on the dates announced on the University's website. Those who do not register within the period shall be deemed to have lost their right.
3. The documents required for registration are announced on the University's website.
4. Online application and placement can be made by the University Senate for the vacant quotas due to the lack of applications for the quotas and/or the non-registration of the placed candidates.

• An "Acceptance Letter" will be sent to students placed in any program through the system. With this letter of acceptance, a "Student Visa" must be obtained from the Turkish Embassy / Consulate. This visa is absolutely necessary when entering Turkey and during registration. Student Visa is not required for candidates who are currently in Turkey. However, the residence period must be valid.

The documents required for registration are:

1. The original of high school diploma or temporary graduation certificate and its Turkish translation approved by notary public or Turkish Foreign Representatives,
2. The original of the high school diploma, the Equivalence Certificate obtained from the Provincial Directorate of National Education of the Ministry of National Education of the Republic of Turkey or the Turkish Foreign Representatives,
3. An official transcript (transcript) approved by the high school directorate, showing the courses taken in high school, grades and grade point average of the candidate, and a copy of the Turkish translation approved by the notary public or Turkish Foreign Representatives,
4. Those who are TRNC nationals, residing in the TRNC and have completed their secondary education in the TRNC and have GCE AL exam results, and those who have or will have GCE AL exam results by enrolling in colleges and high schools in other countries between 2005-2010 a certified copy of the Turkish translation from the notary public or Turkish Foreign Representations,
5. The printout of the İÜYÖS Foreign Student Exam result document,
6. A copy of the pages of the Visa Passport showing the identity information and validity period, and the Turkish translation approved by the notary public or Turkish Foreign Representatives,
7. A copy of the internationally valid Foreign Language Certificate and Turkish Proficiency Certificate, if any, approved by the notary public or Turkish Foreign Representatives,
8. Two 4.5x6.0 cm photographs (must be taken within the last six months, from the front, in such a way that you can easily introduce the candidate),
9. Bank receipt showing that the tuition fee has been paid to the relevant bank,
10. Documented Identity Registration Sample from dual nationals who are foreign nationals by birth and later acquired Turkish citizenship,
11. Transactions of those who submit falsified, fake, incomplete and incorrect information and documents during the application, placement and registration process will be canceled even if the final registration has been made.
